MINUTE 97 – REPORT FROM COUNTY COUNCILLOR

- County Councillor S Hayes appreciated the work from the council with regard to the Treaty event.
- Hill Farm planning application had been passed by Powys CC, and this should be accepted as part of moving on.
- Email received re tractors speeding through Montgomery during harvest times in particular. Without photos etc it is difficult to take this any further.

- Area of land at Station Road and Pool Road has been passed to Community Garden Initiative, hedge is a concern Cllr Weston advised this would be dealt with between Powys CC and CGI.
- Cllr Hayes asked if council could give some thought to The Brades, Chirbury Road, could they consider options for this property.

MINUTE 98 – HIGHWAYS

Civic Society and Freemen have spoken to the Conservation Officer at Powys CC re siting this Plaque on the front wall of the Town Hall and she had advised verbally that she could not see a problem with this. The wording on the Plaque would be in three languages – Hungarian, Welsh and English.

Councillors agreed to meet in daylight to view a poster size version of the Plaque in situ on the Town Hall. Possibilities of other sites was discussed.

Councillors agreed that it had been inappropriate for the groups concerned to contact Powys CC without discussion and also agreed listed building consent would be required. It was agreed to write to Mr. Fairbrother (Civic Society) requesting information he had received during his time as Mayor of this Council and Mr. Davies (Freemen) advising a decision would not be taken until later in the year.
